FCCS, Inc. Financial Update

- Our year end is June 30. The audited financial statements are completed and available on the website for the year end June 30, 2020.
- The auditors were able to issue an unmodified opinion which is the highest level of assurance able to be given. Sometimes also referred to as a "clean opinion".
- Our 20/21 preliminary budget was presented and accepted by FCPS in August 2020.



Play Area Expansion Phase 2












Kindergarten Reading & Math I-Ready




Reading Diagnostic Scores – Grades 1 - 4




Reading Diagnostic Scores – Grades 5 - 8




Math Diagnostic Scores – Grades 5 - 8

School Improvement Plan (SIP) Priorities

School Culture Goals

- 85% of students are fully engaged and actively participating in instructional program/courses.
- 95% of students will participate in home base and town hall meetings

Student Achievement Goals

- The percentage of students meeting or exceeding expectations on Reading i-ready will increase by 5% or more from BOY administration to EOY Administration.
- The percentage of students meeting or exceeding expectations on Math i-ready will increase by 6% or more from BOY administration to EOY Administration.

SIP Priorities CONTINUED

 In grades 3-8 the Identified subgroup populations (Special Education, FARM, Hispanic, 2+ Races, African American) will demonstrate an 8% or greater gain in meeting or exceeding on both the Math and ELA I Ready Assessment from BOY to EOY.

Health & Wellness Goals

- Physical Activities Goal: We will promote physical activity (above and beyond the instructional program) in our school.
- Nutrition Promotion/Education Goal: We will promote nutrition education in our school
 - Share messages verbally about nutrition and healthy eating through morning announcements (ie: Wellness Wednesdays or Fit Fridays), school assemblies, newsletters/ materials sent home, staff meetings, and/ or parent conferences
 - Provide visual reminders, nutrition promotional posters, and/or student artwork promoting healthy eating

Reopening Plan Update

- Students will physically attend school 2 days per week/ attend virtually 3 days per week
- FCPS is scheduled to send out another survey to solicit parent feedback on hybrid vs. face to face instructional participation
- Classroom maximum is 11 students with additional desks being removed
- Students may have to shift homebase depending on student counts
- Scheduling may have to be adjusted based on participation numbers
- Transitions will be minimized and student belongings will have to be kept on their person

Reopening Plan Update CONTINUED

- Fine Arts classes will be taught in the classroom
- Additional desks will be moved into the cafeteria to accommodate socially distanced lunch
- Master schedule will have to be adjusted to accommodate lunch in the cafeteria and needed cleaning protocols.

Upcoming Business of the Membership

- Bylaws revision (Winter)
- Trustee elections (Spring)

Temporary Voting Procedures

- Provide 10 days advance notice of business items and voting window
- Hold member forum online to review business items
- Voting window and procedures will be clearly communicated
- Votes will be cast online via Squarespace and Google tool suite
- Quorum will be counted based on the number of votes cast during the voting window
- Membership status will be confirmed with school records
- Results will be communicated to the membership via email
